- Paper MUST strictly follow 2-column IEEE template.
- Enter copyright notice on paper as in IEEE template.
- Enter any acknowledgements for funding source (e.g., NSF, NRC, and SRC), if applicable. Once paper goes to proceedings it CANNOT be modified.
- If title, abstract, and keywords of the final paper is different from the version submitted to EDAS during the review phase, you may edit those. However, no new authors can be added.
